Members will find a few great Examiner-related benefits in the Members Only section of NACVA's web site. One benefit is that members can access the current issue as well as past issues stretching back to 2003. If you're wrestling with a particular problem or concern, *The Value Examiner* archives offer a valuable, rich resource for assistance and support.

A second benefit is the opportunity to receive up to five hours of NACVA Continuing Professional Education (CPE) for answering a few short questions related to each issue*. Corresponding with each issue is a link to the CPE exam. Simply read the issue, answer the questions, and follow the instructions to send the completed exam back to NACVA along with the fee, which is \$76.50 for members; \$85 for non-members. (Please note that for issues that precede January/February 2014, NACVA's address has changed. Please scan and e-mail your completed CPE exam to NACVA1@NACVA.com, or fax to (801) 486-7500, or mail to 5217 South State Street, Suite 400, Salt Lake City, UT 84107).

Members can also create their own customized CPE exam based on a particular topic. On the *Value Examiner* past issues landing page, there is a link in the upper-right corner titled "Examiner® CPE On Demand Database." Members can perform a keyword search to access all past articles on a particular topic. Simply perform your search and select the articles you'd like to read by clicking the PDF link under the "Link" column. When you're ready to take the exam, check the box under the "Exam" column and click "Create Exam." This will build your own custom CPE exam. The cost is \$15 per exam and members receive one hour of CPE credit for each article they complete*.

Both of these features offer a quick and convenient method for members to gain additional NACVA CPE hours* to maintain their NACVA credential(s).
